Project Description: The County proposes to construct a new, 2-lane bridge across the Russian River on Washington School Road near the community of Asti in Sonoma County. The new bridge would replace the current, seasonal crossing, also known as the Asti Summer Crossing (ASC). The purpose of this project is to enhance safety and connectivity in Sonoma County and to eliminate the financial cost and environmental consequences of the ASC.

This is to advise that the Sonoma County Board of Supervisors has approved the above-described project and has made the following determinations:

1. The project will not have a significant effect on the environment.
2. An Initial Study and Mitigated Negative Declaration were prepared for this project pursuant to the provisions of CEQA.
3. Mitigation measures were made a condition of approval of the project.
4. A Statement of Overriding Considerations was not adopted for this project.
