DESCRIPTION OF NATURE, PURPOSE AND BENEFICIARIES OF THE PROJECT:

The proposed project is the drilling and construction of a new well for existing single-family dwelling.

EXEMPT STATUS:

Categorical Exemption Section 15302(c) and 15303 for replacement or reconstruction of existing utility systems and/or facilities involving negligible or no expansion of capacity, and for new construction of small facilities or structures.

REASON WHY THIS PROJECT IS EXEMPT:

The proposed project is categorically exempt from the provisions of the CEQA Guidelines pursuant to the Provisions of Title 14 of the California Administrative Code, Section 15302(c) (New Construction or Conversion of Small Structures) and 15303, which provides for the replacement or reconstruction of existing utility systems and/or facilities involving negligible or no expansion of capacity, and or new construction of small facilities or structures. The proposed project includes the drilling and construction of a new well to support an existing single family residence. The new well replaces an old well in a different location on the parcel. There is no reasonable possibility that the project would have a significant effect on the environment. No exceptions listed under Section 15300.2 apply.
