## DESCRIPTION OF NATURE, PURPOSE AND BENEFICIARIES OF THE PROJECT:

Senate Bill 9 Urban Lot Split (Minor Subdivision) of an existing 0.46-acre parcel resulting in two lots 0.22-acres and 0.24-acres in size. An existing single-family dwelling on Parcel 1 and an existing single-family dwelling on Parcel 2 will remain and continue to be served by the Valley of the Moon Water District and by on-site septic systems.

## REASON WHY THIS PROJECT IS EXEMPT:
