DESCRIPTION OF NATURE, PURPOSE AND BENEFICIARIES OF THE PROJECT:

Use Permit to allow for the construction of an intermediate freestanding commercial telecommunication facility located inside a 45-foot-tall faux water tank within a 625-square foot lease area enclosed by an 8-foot-tall wooden cedar fence on a 5.26-acre parcel. The request is also to allow for both a portion of the proposed 8-foot-tall wooden cedar fence and a PG&E mounted transformer to encroach a maximum of 5-feet into the required 30-foot property line setback and 5-feet into the required 55-foot front street centerline setback from Los Alamos Road. No water or sewer service will be required. This proposal is for an unmanned facility.

EXEMPT STATUS:

Categorical Exemption Section 15303(e) for New Construction of Small Structures

REASON WHY THIS PROJECT IS EXEMPT:

The proposed project is categorically exempt from the provisions of the CEQA Guidelines pursuant to the Provisions of Title 14 of the California Administrative Code, Section 15303(e) (New Construction or Conversion of Small Structures), which provides for the construction of small structures.

No exceptions listed under Section 15300.2 apply. There is no reasonable possibility that the project would have a significant effect on the environment.
