DESCRIPTION OF NATURE, PURPOSE AND BENEFICIARIES OF THE PROJECT:

The proposed project is a Use permit to legalize a 6-foot fence, permit additional 6-foot fencing and permit a connecting 6 foot gate within the front street centerline setback on a 5.43-acre parcel. Fence is to be constructed using wire with 4 inch by 4 inch fence posts placed 6-8 feet apart. Gate is proposed to be constructed using cedar boards and 4 inch by 4 inch steel posts. Related files VPL23-0418 and VPL23-0419.

EXEMPT STATUS:

Categorical Exemption. Section 15303 of the CEQA Guidelines, which provides for construction of accessory fences. There is no reasonable possibility that the project would have a significant effect on the environment.

REASON WHY THIS PROJECT IS EXEMPT:

The proposed project is categorically exempt from the provisions of the CEQA Guidelines pursuant to the Provisions of Title 14 of the California Administrative Code Section 15303(e) (New Construction or Conversion of Small Structures) The project includes replacement and negligible expansion of an existing fence, in the front yard in a rural residential area. No exceptions listed under Section 15300.2 apply. There is no reasonable possibility that the project would have a significant effect on the environment.

This Notice of Exemption is filed pursuant to the provisions of Section 15062 of the State CEQA Guidelines.
