## NOTICE OF INTENT TO ADOPT A MITIGATED NEGATIVE DECLARATION PURSUANT TO THE CALIFORNIA ENVIRONMENTAL QUALITY ACT (CEQA)

WHO: Project Proponent, Sonoma County Public Infrastructure

District 2.

WHAT: At the intersection of Adobe Road and Main Street/Petaluma Hill Road in unincorporated Penngrove the project proposes the construction of a dedicated right turn lane for westbound

vehicles on Adobe Road turning right on to northbound Petaluma Hill Road which requires widening the road, extending a box culvert at the northeast corner of the intersection, and constructing a retaining wall at the northeast corner continuing east along the northside of Adobe Road. In addition, the project proposes to construct a dedicated right turn lane for northbound vehicles on Main Street turning left on to westbound Adobe Road within the existing pavement limits. Included in the project is upgrading curb ramps and pedestrian landings to the latest Americans with Disabilities Act (ADA) requirements and installation of bike lanes in accordance with the latest Sonoma County Bike and Pedestrian Plan. **Supervisorial** 

In accordance with Public Resource Code and CEQA Guidelines, the County of Sonoma provides notice to agencies and interested parties that it is releasing a final Initial Study and Mitigated Negative Declaration (IS/MND) for the project. The IS/MND did not find potential environmental impacts that could not be mitigated to a less-than-significant level.
