WHAT: Request for a 5-year limited term Use Permit for a commercial cannabis operation consisting of 10,000 square feet mixed light and 5,000 square feet indoor cultivation, accessory propagation, and centralized processing of cannabis in new structures on the former Bloomfield Quarry site. The operation does not include any outdoor cannabis cultivation. The operation would hire up to 19 employees. Hours of operations would generally occur during daylight hours from 8:00 am to 5:00 pm and 7:00 am to 7:00 pm during harvest periods. Deliveries would be limited to 8:00 am to 5:00 pm Monday through Friday. No public access or retail sales are permitted. The project is located approximately 1 mile northeast of the unincorporated community of Bloomfield on a 113-acre parcel located at **4707 Bloomfield Rd, Petaluma. APN 027-050-022. Supervisorial District 2.**

Parcel Zoning: LEA (Land Extensive Agriculture) with a 160-acre density and RC50/50 (50-foot Riparian Corridor Setback)

In accordance with Public Resource Code and CEQA Guidelines, the County of Sonoma provides notice to agencies and interested parties that it is releasing a final Initial Study and Mitigated Negative Declaration (IS/MND) for the project. The IS/MND did not find potential environmental impacts that could not be mitigated to a less-than-significant level.
